Community activities and opportunities slowly and safely returned, including print making classes at Lawrence Art Center, Music Therapy via Zoom, van rides, community strolls and park activities when possible.

Residential: serving 95 individuals in 45 locations

Health Supports: 836 persons-supported seen in the clinic by HS Nurse

Health Supports: 2,028 health-related appointments scheduled for persons supported (25,409 miles traveled to transport persons-served to health-related appointments)

Nearly 100% of both persons-served and staff have received COVID vaccinations!





In early 2021, COVID vaccines became available for people at high risk, which included the people with I/DD and the staff that support them. Cottonwood hosted 4 onsite vaccine clinics with nearly 100% of persons served in Residential and CW staff receiving the vaccination.

Karrie loves rock and roll and has enjoyed going to many concerts over the years, including KISS.


Her consistent positive attitude, outstanding work ethic and her endearing personality truly make her a shining star.
